1. **Jurisdiction.** The event will be held under the General Competition Rules and Standing Regulations of the Motor Cycle Union of Ireland and Motor Cycle Union of Ireland (Ulster Centre) Limited, these Supplementary Regulations, the MCUI UC Covid – 19 Risk Assessment and any further Regulations subsequently issued.

2. **Eligibility.** The event is open to drivers holding a current competition licence issued by the MCUI, ACU or SACU. The promoters require holders of ACU and SACU competition licences to show evidence of the required Medical Expenses and Repatriation cover before permitting a start.

5. **Entries.** Entries must be made on the official form, complete in every detail and accompanied by the **ENTRY FEE:- Seniors £25 Youth A, B, £15 Youth C, D, E Minders £5. 6. **Classes.** The trial will be for Grades Expert elite, Expert, Semi-expert, Clubman, Sportsman, Youth Grades A, B, C (big course). Junior C, D, E will have a separate course in an allocated area, they must remain in this area while the main trial is in progress. They are not permitted to ride on the main course.

7. **Course.** The course will be marked with direction arrows or flags indicating the desired route between sections.

8. **Start and Finish.** Drivers will be started by timekeeper per rider's numerical order and sign off by presenting riding number card at the finish particularly on retirement.

9. **Time.** The time allowed to complete the trial shall be announced at the start. **Anyone who does not start at the due time will receive no allowance of time for late starting.**

10. **Sections.** The No of sections and laps to be defined at start, must be attempted in the correct order. The sections will be indicated by **Start Markers** at the start and **End Markers** at the finish. In between coloured gates to coincide with rider's bib colour.

11. **Awards, Trophies by request only, eligibility as below.**
